The ornamental design of a game table with handle for scrolling games thereacross, as shown and described.

**DESCRIPTION**

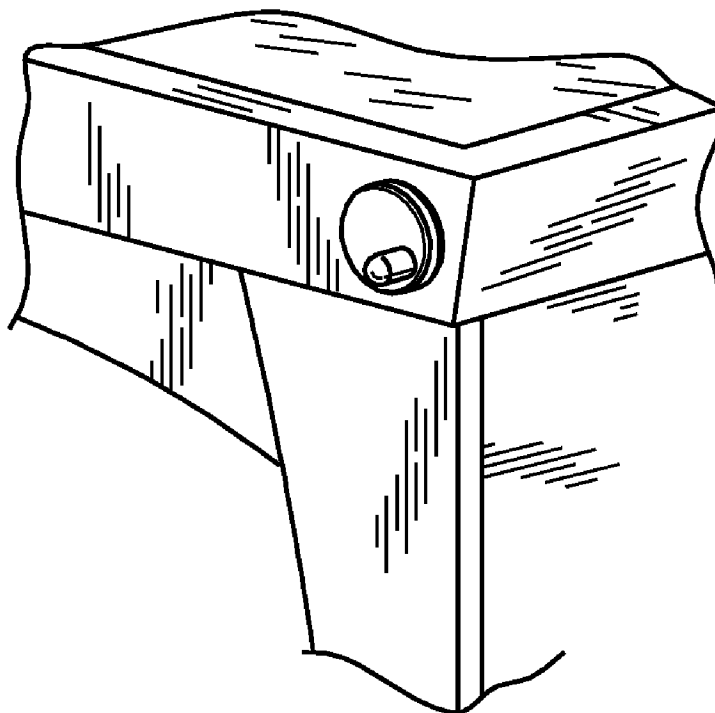

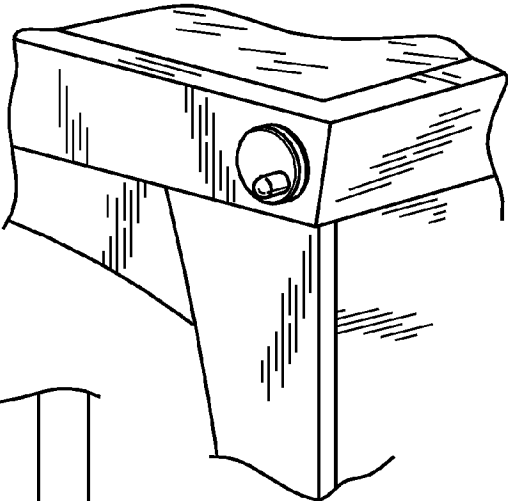

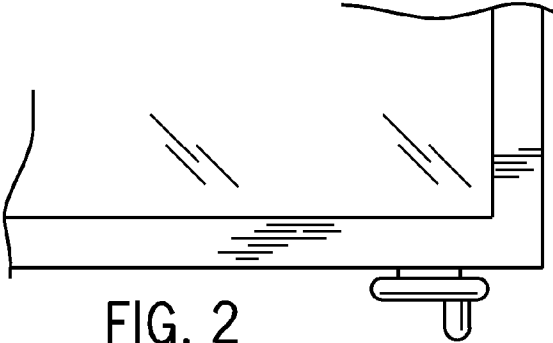

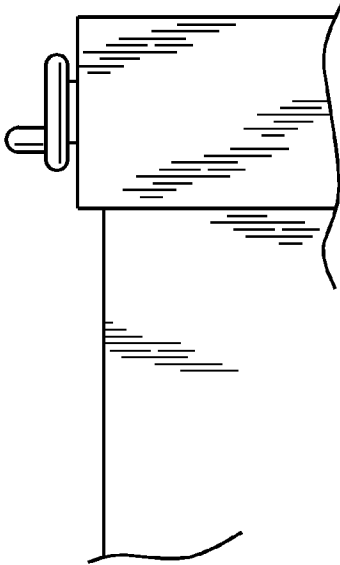
